

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to rebeccaittner.com, and RJI Designs, LLC and governs data collection and usage. By using the rebecca.ittner.com website (herein called Site), you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, rebeccaittner.com may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- Email Address
- Phone Number

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. Sharing Information with Third Parties

Rebecca Ittner Photography does not sell, rent or lease its customer lists to third parties.

Rebecca Ittner Photography may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Rebecca Ittner Photography, and they are required to maintain the confidentiality of your information.

Tracking User Behavior
